  - b. Cash payable to investors holding custody accounts through Nasdaq Dubai Custodians will be paid to such Custodians. Where payments are required to be made in a currency other than the currency that Nasdaq Dubai receives from the Issuer, the applicable conversion rates provided by Nasdaq Dubai's processing banks will apply.
